EMERGENCY HOUSING VOUCHER PROGRAM INCENTIVES

If you rent your unit to an Emergency Housing Voucher (EHV) family, you may be eligible to receive the following incentives:

- Up to \$5,000 One-Time Reimbursement for New Contract Inspection Repairs;
- \$2,500 Signing Bonus for Each EHV Leased;
- Reliable Monthly Payments;
- Application Fees Up to \$50.00 per adult; and
- Utility Fees, Deposit Plus Any Past Due Amount.
