#### NEW ONLINE RENT CAFÉ PORTAL COMING JANUARY 2022

### EMERGENCY HOUSING VOUCHER PROGRAM INCENTIVES

- Up to \$5,000 One-Time Reimbursement for New Contract Inspection Repairs
- \$2,500 Signing Bonus for Each EHV Leased
- Reliable Monthly Payments
