### **Apply Now: FREE Lead-Based Paint Remediation**





Owners of multifamily properties with five or more units may be eligible for up to \$25,000 per unit for the remediation of lead-based paint hazards in the interior and exterior of units and health and safety improvements. The costs of the lead-based paint inspections as well as all construction activities (including relocating your tenants if necessary) to remove any identified hazards are **100% covered**.

Properties will receive free testing for chipping or peeling lead-based paint hazards for enrolled properties. If any hazards are found, the remediation program will provide the certified contractors, all materials, and inspection services to remediate lead-based paint hazards inside and outside of your units and other related repairs that caused the lead-based paint to deteriorate.

### **LA COUNTY RENT REGISTRY: What You Need to Know**

The Department of Consumer and Business Affairs (DCBA) recently launched the LA County Rent Registry, a new online portal that allows owners of properties located in unincorporated LA County to register rental properties and unit information, and pay any annual rent registration fees required by the County's Rent Stabilization and Tenant Protections Ordinance (RSTPO) and Mobilehome Rent Stabilization and Mobilehome Owner Protections Ordinance.

The Los Angeles County Development Authority (LACDA) is in compliance with the Rent Registry requirement and may deny a rent increase for a rental unit in the future if it does not meet the rent registry requirements. Landlords and mobilehome park owners who rent units or mobilehome spaces within unincorporated areas of LA County **must** register and pay registration fees annually. An exemption request can be submitted through the Rent Registry for review.

Please note, if you ever rent your unit(s) or space(s), you will be required to register within 30 days of the tenancy start date. Landlords may impose an annual rent increase only upon registering the Fully Covered Rental Unit in the County's Rent Registry System, paying required annual registration fees pursuant to Section 8.52.080, and being in compliance with Federal, State, and local laws and requirements.
